The KDI School of Public Policy and Management has expanded its international network by adding additional academic institutions to its list of partner schools. With these new agreements, the KDI School hopes to enhance their role and reputation as a leading institute of public policy and management. The new partner schools include Indiana University and the University of Missouri at Columbia.

With the new partnerships, KDI School students will be able to participate in various academic programs at over twenty different global institutions.

The types of programs available to KDI School students include the Global Master's Program and traditional student exchange programs. Global Master's Program students study at the KDI School for one year and then go abroad to a partner university in their second year. Upon successful completion of the program, graduates are awarded a KDI School degree as well as a partner school degree. In addition to the GMP curriculum, general student exchanges are also available for outbound students. Exchange students are selected in their third term and begin their exchanges in the following semester. Exchange students can enroll in the partner school starting from the winter or spring term, and may continue the exchange for one term or up to one year, depending on the program they choose,

An agreement of cooperation with Indiana University's School of Public and Environmental Affairs was reached in May, and is aimed to promote an academic exchange of research and other resources

between the two schools. Indiana University was founded in 1820 with the mission to offer higher education and services to the public. The similarities in the two school's mission statements will assist each institute's ability to promote joint conferences, seminars, and other works of interest between Indiana University and the KDI School.

In April, the KDI School also established an additional partnership with the Lee Kuan Yew School of Public Policy at the National University of Singapore (LKY SPP). The memorandum of understanding signed by the two schools will allow them to officially exchange students and researchers. The partnership between the KDI School and LKY SPP seeks to enhance each institutes capabilities as centers of excellence for academic study and research on public policy, especially policy in the Asia Pacific region.

Based on the solid links with academic institutions in the United States and European nations, the KDI School is planning to broaden its network into the rest of the world. Partnership talks are currently ongoing with several universities in the traditional partner nations of the United States and Europe. Concurrently, the KDI School is also expanding this base and is engaged in dialogue with universities in Canada, South America, the Middle East, and Asia, particularly in China. As word of the quality of the KDI School continues to expand, additional partnerships are expected. The KDI School is also taking measures to actively promote the school and is currently participating in accreditation reviews, conferences, and the scheduling and hosting meetings with the worldwide academic

KDI School Hosts Korea-Africa Ministerial Conference

The KDI School recently held a Ministerial Conference for Korea-Africa Economic Cooperation to assist African nations in initiatives to further the develop their economies.

Led by President Donald Kaberuka of the African Development Bank, the delegation participated in a two-day conference that shared Korea's experiences in economic development and its views on the government's role in effective economic planning.

"There is a high possibility to expand economic cooperation between Korea and Africa, I hope our discussion will create new opportunities for the Korean government and companies to discover yet unknown opportunities in fast-developing Africa," said Chin-Seung Chung, Dean of



Professor Ji-hong Kim of the KDI School briefed the participants on the history of economic cooperation between Korea and Africa since the 1970s. He also added some comments on the future of relations between the countries.

"Korea can assist Africa to pursue institutional reforms in a variety of areas, such as in government reform, in the eradication of corruption, and in property and contract rights

He added that the food processing industry, petrochemical plants, and human resource development were also major areas that had ample development potential.

The delegation expressed mutual willingness to expand the already existing connections between Korean enterprises and African consumers. Korean corporate participants exchanged their views on cases of recent investment projects in infrastructure, mining, agri-business, financial systems, investment funds, and tourism. The group also relayed its desire to tap the abundant economic opportunities in infrastructure, energy, telecommunication technologies,

The average real GDP growth rate across Africa was forecast to reach 5.8 percent this year, with many nations also currently in a period of political stability to allow for sustained growth.

NOTIFICATION KDI School Seminars: Research Seminar and Global Issues Seminar Series

The Social Science Research Network (SSRN) recently announced the KDI School as 1s among all business schools in Korea, 6 among all schools in Asia, and 38th in overall non-US International Business Schools based upon the number of downloaded faculty research papers by KDI School professors.

Rankings are seen as extensions of the academic community's sentiment on the quality of the research of each institution. Although a comparatively young school, the KDI School has quickly been able to establish itself as an institute of higher academic education and quality research

Since its inception, the KDI School has been diligent in fostering solid academics and quality outputs by its faculty, students, and staff. In addition to the highly qualified faculty, a 1:9 faculty to student ratio, and expansive support structures, the school administration has adopted policies to strongly support faculty research initiatives.

The research atmosphere is further encouraged by the KDI School's performance evaluations which motivate faculty members to maintain high standards in the quantity and quality of their academic research. Faculty who publish in top tier journals are provided with additional benefits and compensation,

To share this research, the KDI School also holds research seminars on a weekly to biweekly basis every Friday during the school semesters.

KDI School professors host the seminars for students, faculty from other schools, and the general community to enjoy a casual lunch while listening to summaries of research initiatives. The seminar presentations and discussions enable participants to keep abreast of the latest research projects and developments, while also allowing the faculty to fine-tune working papers ahead of official publication submissions.

The seminar series also invites outside researchers to discuss their papers and present their findings to the open forum. This includes guests from the Bank of Korea, IMF, National University of Singapore, Temple University, Stanford Law School, Hitotsubashi University and many others. Professor Woochan Kim, in charge of organizing research seminars, points out Mark Noland, Korea economy specialist from IIE (Institute for International Economics) as one of the memorable outside speakers. His presentation entitled, "Religion, Culture, and Economic Performance", was very well attended and warmly received by the KDI School community.

In addition to the Faculty Research Seminars, the KDI School is also hosting a new Global Issues Seminar Series - Spring 2006 (GISS), sponsored by the World Bank External Affairs office. The series is tentatively composed of 13 topics, spanning from April to June, 2006. The series will cover four broad themes of the Global Economy, Global Human Development, Global Environment, and Global Governance,

GISS connects experts at the World Bank and participants from six Asia-Pacific countries through multi-linked video conferences. Forums and seminars are held around the world and allow the presenters and participants to embrace the ideas and findings from peers without limit to boundaries and time. The program format includes seminar presentations followed by detailed Q & A sessions.


►► Alumni Gathering in Beijing and Bangkok

▶▶ An Interview with Professor Wook Sohn

"Learning by yourself is very important, but sharing your knowledge and working with your friends are not less important."

Q. What made you to come to the KDI School?

Before I came to the KDI School, I worked at the Bank of Korea for ten years as an expert in monetary policy. After that, the bank sent me to the United States to study economics at Columbia University. After graduating, I came back to work for the Bank for two additional years and then came to the KDI School.

One of the most important reasons for coming to the KDI School was to perform high-quality research and give lectures. I love performing research, especially on financial issues.

Q. What is it like to be a professor at the KDI School?

Actually, this is my third semester at the KDI School. In the first semester here, I gave lectures on fixed income and FX analysis. Currently, I am giving lectures on "Capital Market and Management". Teaching is something new to me, but I love working with students and sharing my knowledge with them.

The KDI School is especially interesting since the covered issues are not only theoretical, but also practical issues. It is truly a wonderful opportunity to share my practical experience with students since students of the KDI School have working experience as well. Frankly speaking, I enjoy teaching here, I realize that I can also learn from my students and that we each can teach each other many things,

Q. What is one of the most interesting aspects you have discovered about the KDI School during your time here?

At the KDI School, I have a chance to fully utilize my practical and theoretical knowledge. The KDI School is a graduate school. As a result, I have an opportunity to do research in my fields of interest.

Moreover, all the lectures are given in English, which is also a benefit for me. Additionally, KDI School students are hard working and always eager to learn new things, which really impresses me.

Q. What is the most memorable moment you had during your time of studying in the US?

When I look back at my 6 years of studying in New York, the most memorable thing I recall is how hard I studied. I had to try very diligently to adapt to my new life and studies, I studied more than 10 hours a day,

The following years were more relaxed, and I started enjoying the social life there by learning Japanese and taking part in some club activities. Now I sometimes miss those days, since a student's life appears to be the most beautiful period of life.

Q. Do you have any advice you wish to give to the KDI School students?

I see that many KDI School students want to become the leaders, and I believe that they will achieve this in the future. Some of them are leaders at right now, and it is a pleasure to have them in my class. However, in order to be a good leader, they should first learn to become a good servant, If you are a good servant, you will have a deeper understanding about the world out there. Then you will become a better leader.

Also, I encourage KDI School students to be more open to others in terms of group study. It is crucial to learn on your own, but I am sure that you can learn much from your friends as well. Once you study with your friends, everyone can share their knowledge with one another and gather different perspectives. Moreover, studying with others helps you to know what level you are at and what parts of the lessons you should focus on,

You may be at peace and feel comfortable if you know what to do and how to do it. As creatures of habit, we cannot easily free ourselves from our familiar, everyday lives, "Deviation" in the song of Korean musician Jawoorim, is hardly carried out in real life,

However, we also know that there are people who break out of their molds of so-called everyday life. It is a pleasant privelage of KDI School to house those brave people, since the KDI School has many students who long for changes in their lives.

This article shares the stories of our alumni who kept looking for challenges and applied for exchange programs at the KDI School, Mr. Shin, one of our interviewees, started his career in the U.K. two years ago, Ms. Kim ended up on a short term exchange that has led to much more, Let's observe how they've built their futures and assisted both the KDI School student body and themselves,



Ki Ha Shin (2002 MBA)

Ki Ha Shin worked as a marketing consultant in Korea before studying SM (Strategy and Global Management) from the MBA program at the KDI School in 2002. He went to Germany in September 2003 for the exchange program with HHL Leipzig Graduate School of Management, HHL is the oldest business school in Germany and boasts of offering a general management training program of the highest academic standard. After he finished this program in June 2004, he started his new career in the U.K. He is currently working as a credit analyst in Vanquis Bank, whose parent company is Provident Financial.



Seung Hee Kim (2003 E-MBA)

Seung Hee Kim worked in the communication and broadcasting industry for 8 years before deciding to apply to the evening MBA program of the KDI School in 2003. After one-year of study at the KDI School, she caught hold of another great opportunity to study in ISC (Institut Superieur de Commerce) in France as an exchange student in October of 2004. She currently is still in Paris and plans to study more at ISC for a dual degree.

Q1. How did you make up your mind to study again? Why at the KDI School?

Shin: Before entering the KDI School, I strongly felt that there would be no reaping of rewards if there was no trial. It was a turning point in my life. Frankly, I felt that I could be left behind by the competition, surrounded by people who could speak English or other foreign languages. Competition required me to become more intelligent and knowledgeable. Consequently, there was no other choice besides the KDI School, where all the classes of professional business management are taught in English.

Kim: A newspaper article informed me of the KDI School. I was delighted with the evening MBA program of the school, It would allow me to manage my job and family matters, while also studying at a world-class institute.

I recently saw the notice for the "Press Release Campaign" on the school website. Through the efforts all alumni have made, I hope that the KDI School can further expand its reputation, I also hope that more people will make the right choice for their continuing education.

Q2. What do you remember first when you look back upon your time at the KDI School, For example, is it classes, club activities? What?

Shin: With my previous work experiences, the practical academic curriculum and case study method was relevant to me, It was quite different from the lecture style of other Korean schools at that time. I enjoyed the classes given by Prof. Lee, Seung Joo and Prof. Jung, Kwon much, and I learned how to think strategically to solve problems in the real business world

Kim: I was very motivated to study hard, more than any other time in my life. It was a perfect time for me. I needed to refresh myself with new knowledge and experiences after working for 8 straight years. I can tell you that I made the best use of my school life in terms of studying, mainly related with the Strategic Management concentration of the MBA course. However, I was fully occupied with my work and study; I could not spare additional time for other school activities. Fortunately I joined a cultural exchange club in Paris and met wonderful people through the activity. Now I'm fully enjoying my student life here.

Q3. What made you to apply for the exchange program? Is (or was) your school life in Europe what you have expected before?

Shin: From the beginning, I did not expect to make an academic commitment through an exchange program since I had already studied 3 semesters at the KDI School, Rather, I perceived the

exchange program as a chance to become accustomed to life in Europe and to find a job outside of Korea. Up till now, it has been successful. After the exchange program, I started my international career in the U.K.

Kim: My husband was posted to Paris and so I had two options to finish my study. One was to stay in Seoul alone and finish my 4th semester. The other one was to apply for an exchange program. However, the problem was



that there was no exchange school in Paris, After I consulted with Professor Yoon, who was in charge of exchange program at the time, she and other staff helped me look for partner schools in Paris. We eventually made an agreement so that I could continue my studies at (ISC) in Paris.

I really appreciate the professors and staff at the KDI School who actively helped me, ISC is now uploaded as one of exchange programs at the KDI School. Other students can also apply to ISC for their own study and cultural experiences in Paris.

I would like to say a little bit about ISC's academic program, ISC offers 18 concentrations of its MBA program and master's course, "3emes cycles" such as sport management, finance, luxury brand management, human resources, and so on. Both MBA and 3emes cycles are available to exchange students. Courses are offered in English; however, if you can speak French, you will benefit a lot more. The first semester begins in September and lasts until December, the second semester from January to May. There is a one or two-week break in the middle of each semester for Christmas and spring holidays, A 3 to 6 months internship is required for the dual degrees programs. I hope this brief information will be helpful for potential students.

Q4. What is your future career development plan in the long term?

Shin: I plan to continue cultivating my international career for approximately 10 years longer. Then, I assume that it will be time to decide whether to return to Korea or not. So that I have the possibility of returning to Korea, I have chosen companies with good reputations in Korea as well as ones offering good positions for my career path.

Kim: The KDI School and ISC have finalized their agreement on dual degree programs in May of 2006, I applied for the dual degree program a few months ago after finishing the exchange program during the last two semesters. Fortunately, I have the luck to study for 3 years, the entire duration of my stay in Paris, without any

I am considering Luxury Brand Management as my concentration for the dual degree program. After returning to Korea in 2 years, my plan is to do business between France and Korea, I guess I found the relevant program and concentration in ISC. Studying in Paris started up with my husband's overseas appointment, but it also became an essential time for me as well.

Q5. Do you have any advice for anyone considering an exchange program or developing his or her international career?

Shin: Participating in an exchange program will make you contemplate things from an international point of view and also open your chances of getting a job in other countries. Because of the language barrier, many Korean people tend to choose the English-speaking world at first. If somebody can speak other languages, then the story will be different. Regardless, as times goes by, you may want to be promoted to managerial positions. It means that you will need to know how to lead your team members. Again, communication skills and language barriers will appear in front of you as a requirement for those upper positions. So start earlier, be prepared as soon as possible, and plan your career path in the long term. If you have a suitable experience in a certain field in Korea, it will shorten the time for you to overcome the barriers.

If you are hesitating due to financial problems, turn your interest to universities located in Europe and Mexico and not the U.S. No extra tuition will be charged then. That is the strategy I chose.

Kim: The French love and try to keep their culture and language preserved. You will find the truth of this sentence personally within a few hours of arriving in France. It was just a few days after our arrival in Paris and I did not know how to speak even a very simple conversation in French, I soon received a lecture from a librarian when I spoke in English to borrow books, "You are in France, you should speak French." Even in the classrooms, some French students ask questions in French sometimes. So I would say this again, if you know the language, then you will get more. However, according to a different point of view, it could also be a good opportunity to learn French. The exchange programs in France will enable you to speak one more foreign language. So why not take a

Q6. Let's talk about something besides studying and working, What would you recommend for us to do when we visit Europe? Please give us a sightseeing tip as a resident in Europe.

Shin: Do not miss classical music concerts in Germany, It may open your ears to the fascinating world of classical music. I was moved deeply by the melodies in concerts, If I found Korean musicians who played music with other



members of the German orchestra, then the sound of the music meant the sound of my mother country to me. My heart was palpitating with a great emotion. I hope that you can also feel what I felt with your own senses too.

Kim: "Feel the pleasant wait." You need to know this concept to enjoy a pleasant stay in France. Normally, metropolitans are surrounded by an atmosphere where everything is going very fast, especially in Korea. However, you need to forget about that for a while and enjoy and recover your composure while you're in France, Then, you will be able to see that there are more than 100 museums just in Paris. It would be good idea to plan a specific cultural trip with a certain theme like the art of the impressionists or

Expert Debate and Polling Forum on the Korea-U.S. FTA

The KDI School hosted an open forum regarding the proposed FTA agreement between Korea and America, sponsored by the JoongAng Daily News on July 4, 2006.

Prof. Jin Park, Director of Center for Conflict Resolution and Negotiation, moderated the forum, which invited four experts in the field, including Hye-Min Lee, Director-General of the Office of the Korea-U.S. FTA. Almost 200 participants from Korea University, KAIST, Hankuk University of Foreign Studies, and others attended the four-cornered debate. Afterwards, a survey was conducted that was later reported in major Korean dailies.



Korea's Rise to a Knowledge Economy Seminar

Korea achieved rapid economic development and established a knowledge-based economy in a short period of time. Korea successfully absorbed advanced knowledge and technology from abroad and fully commercialized them with effective Human Resource Development systems in knowledge innovation. Korea's case can be a useful model for industrializing and semi-industrialized countries.



With all this in mind, the KDI School and the World Bank held an official launching seminar for Korea as a Knowledge Economy, a published text that contains Korea' economic development processes, experiences, and new growth policies.

As part of Korea' knowledge sharing commitment with other countries, the KDI School and the World Bank organized this seminar and book launching to assist in reducing worldwide knowledge gaps. The seminar paid special attention to building and upgrading knowledge innovation capacities, as well as in turning knowledge and technology into businesses in Korea and participating countries.

The KDI School hopes that these experiences will enhance national competitiveness, as well as the economies and social development of many growing countries.

Workshop on Dual Development Agenda and Developing Country Positions for WTO Negotiations

From July 4 to July 14, 2006, the KDI School held the "Workshop on DDA and Developing Country Positions for WTO Negotiations", co-hosted by KOICA, and sponsored by the Colombo Plan.

In the workshop, 12 government officials from Asia Pacific Nations discussed core issues of WTO Trade Remedy Agreements and several dispute settlement cases.



This workshop on International Trade and WTO Agreements Implementation consisted of 12 lectures, on topics such as the WTO Dispute Settlement System, Non-Discrimination, and Trade Policy & the Korean Trade Remedy System.

Workshop on International Trade and WTO Agreement Implementation for Indonesian Officials

The KDI School organized the "Workshop on International Trade and WTO Agreement Implementation for Indonesian Officials", co-hosted by the Korea International Cooperation Agency (KOICA) from June 16 to July 1, 2006.

This workshop was designed to provide the necessary understanding and analytical capabilities to participants who practice in relevant subject areas. Prominent practitioners and academics discussed core issues of the WTO Trade Remedy Agreements and several dispute

The workshop provided 20 government officials from Indonesia with greater knowledge and practical case studies on what currently underlies trade remedy issues.





Korea Indonesia Knowledge-Sharing Project

The KDI School hosted the Final Review Workshop for the Indonesia Ministry of Finance from May 9 to May 11, 2006. This workshop was aimed at discussing draft reports and gathering policy recommendations on the Korea-Indonesia Knowledge-Sharing Project,

The on-site workshop, which followed the final review workshop, allowed Indonesian officials to meet the Korean officials who actually administer the policies of relevance of the specific projects, They discussed Korean experiences with the policies and visited two of Korea's industrial giants.

13th Program on Economic Policy

The KDI School will be offering the "13th Program on Economic Policy" targeting managers who wish to build a stronger understanding of policy-making and policy coordination. The deadline for applications is August 25, 2006.

An Interview with Students from Yanbien

Reported by Do Kim Ngan (2006 MPP)



Yanbien is a district in northeast China that borders Korea by the Tumen River. During the Korean War, many Korean people immigrated to China and settled there. Their children and grandchildren were born and educated in Yanbien. This has created a unique Korean-Chinese ethnic group among the 54 ethnic groups of China. This community accounts for 5 percent of the entire population of China.

Yanbien is one of the unique areas of China with various foreign exchanges, There e. Chinese residents and Korean Chinese residents, who are ethnically Korean but hold

are two main elements to the population: native Chinese residents and Korean-Chinese residents, who are ethnically Korean but hold Chinese nationality.

Yanbien University of Science and Technology was the first university founded by a foreigner, Dr. Chin Kyung Kim. Professor Kim is a Korean-American, He was involved in the Korean War and moved to China in 1980s. In 1992, he established the university using his own assets in order to create a globally recognized university for the Korean-Chinese community. About 70 percent of the students of Yanbien University of Science and Technology are Korean-Chinese, with the remaining 30% being of Chinese, Korean-Uzbekistanese, and other backgrounds,

The KDI School recently sat down for a meeting with two students from Yanbien University of Science and Technology (YUST), Cui Hong Mei and Fang Yong Lu, Below is a transcript of the sessions,

Q. Can you tell me something about Yanbien University of Science and Technology?

YUST is the first Chinese-abroad joint venture university in China, YUST is a very global university with famous professors from 15 different countries. This includes the United States, the United Kingdom, Germany, Canada, Korea, Japan, China, and others, These professors have diversified backgrounds, which provide students with specialized learning opportunities. YUST is composed of four main colleges: business, science, linguistics, and nursing, Courses are conducted in English, Korean, and Chinese and allow students to develop their linguistic abilities regardless of their major. Studying at YUST allows us to experience diversified cultures from all around the world

Q. Please give us a brief introduction regarding your backgrounds,



Cui Hong Mei: My grandparents came to Yanbien during the Korean War and I was born and grew up here. From elementary school, middle school, high school, and even university, I studied at schools for Korean-Chinese people. At YUST, I studied

Management, Although living in China, I had a chance to speak to my family members in Korean everyday. That's why I feel very comfortable in speaking Korean,



Fang Yong Lu: I was born in Yanbien as well. Korean is my mother tongue, but I learned Chinese in elementary school and also studied Japanese when I at middle school. At YUST, I studied International Trade and Economics.

Q. How did you come to know about the KDI School?

We were the teaching assistants in the research department of YUST, Professor Shin Jaeun from the KDI School sent an email to our professor to introduce YUST to the KDI School, We both applied and received admission,

Q. Why did you come to the KDI School?

Cui Hong Mei: I came to the KDI School because the MBA course here is very unique. Every subject is lectured in English, which is a good chance for me to improve my English abilities. Also, perhaps my Korean blood somehow pushed me to study in Korea.

Fang Yong Lu: I can speak both Korean and Chinese. I hope that I can contribute to the promotion of economic relationships between Korea and China. I am keen on handling the many areas linking economical and political relations between the two countries. I knew that I could learn and practice those fields at the KDI School.

Q. How do you find life in Korea?

Cui Hong Mei: I find no difficulties in adapting to the culture in Korea since I can speak Korean, I was here 3 years ago and so this is not the first time I came to Korea, Korean life is nothing strange to me because we keep Korean traditions in our family as well,

Fang Yong Lu: I was a past exchange student at Yonsei University and so this is not the first time I am in Korea, I feel at home here because everything is familiar to me.

Q. Do you intend to develop your career here in Korea?

Cui Hong Mei: After graduating with my degree, I hope to find a good job in Korea, If I have a chance, I would like to stay and develop my career here, However, after some time, I will go back to Yanbien to help my university. It is a promise to the school that once every student receives a job, they will contribute 1 percent of their salaries to the school.

Fang Yong Lu: Yes, after graduating from the KDI School, I hope to find a job in Korea. Since I am a fresh graduate, I have no working experience. Thus, I wish to stay in Korea and develop my career.
