Indian Government -Maxell School Joint Education Program

In the last two weeks of May, 120 Indian government leaders came to the KDI School for the Joint Education Program between the KDI School and the Maxwell School of Citizenship and Public Affairs at Syracuse University. The program ran for eight weeks and is a result of the collaborative efforts from both the Indian Institute of Management in Bangalore and the Maxwell School at Syracuse University.

The program provided informative and practical case-studies on Korea's development process after the Korean War, which was an economic drainage.

"Korea is seen as a role model for economic development that could be applied relatively easily compared to the U.S. or

European countries by economic policy-makers in emrging markets like Bangladesh and India." (*KDI School shares development experience*, reported by Jung-Min Kim, the Korean Herald, May 20, 2008)

The IMPM Program also matches one of the KDI School's main objectives which is to provide professional assistance to economic policy-makers of developing countries. The KDI School "is an institute for public policy, one of the important missions of the school is to share Korea's unique development experiences with the international community." said Dean Sang-Moon Hahm of the KDI School.

During the two week event, participants learn about Korea's development experiences, general theories on economic

development and social infrastructure investments. Topics in the program include civil service and administrative reform; management of the financial crisis in 1997; the role of government in various sectors; business and government relations; e-government; economic development and trade; and decentralization of government functions and services. Hopefully participants would be encouraged to apply political initiatives and strategic analysis that they have learnt during the IMPM program to their home countries. "The KDI program is unique," said Mitchel B. Wallerstein, the Dean of Maxwell School," a critical part of this educational experience is what is known as the "exposure visit," this visit is designed to permit participants to gain understanding, make comparative judgments, learn the best practices, develop connections and build closer relationships with various institutions and government leaders."



The KDI School also organized a day trip to the office of the Prime Minister and the Seoul City Council; a visit to Hyundai Motor in Ulsan, Hyundai Heavy Industries, POSCO Pohang Steel Works, Kwangyang Steel Works and Kwangyang New Port; and also a visit to historical sites for the Indian officials.

Interviews with Indian officials

Ajay Jain, Managing Director and CEO of Andhra Pradesh Power Generation Corporation: "I was impressed by the work ethic and emphasis on primary education in Korea. One of the most important lessons I learnt was that Korea achieved massive infrastructure and industrial development in a very short period of time."







Apoorvak Singh, Managing Director of North Haryana Power Distribution Company: "The most salient message was that Korea is a country with an indomitable "can do" spirit. Korea is today counted as an egalitarian and developed society. I believe that Korea has been able to achieve the goal through a harmonious relationship between the government and the citizenry, and effective policy response."

Gonesh Koyu, Secretary to the Government of Arunachal Pradesh: "My impression before the visit was Korea is a stooge of the United States and that its economy was bankrolled by the Americans. How wrong I was, I now know about the fierce pride the country has on its successful transition from an economically backward country to a developed economy all on its own."

Incheon Bridge





On the 14th of May, international students went on a one-day trip to the Incheon Bridge. They firstly visited the Korean Expressway Corporation (KEC) to learn about road development technology. The KEC is Korea's leading research institute specializing in road development. Currently, The KEC and the Ministry of Land, Transport and Maritime Affairs are managing construction of the Incheon Bridge. The students took a boat to the construction site and walked on the bridge which is planned to be 18.2 kilometers long. They were very impressed with and astonished by Korea's advanced technology in road development. "It is unbelievable. I have not seen such an incredibly beautiful cross- sea bridge like this ever. It is so big and long, yet I found only few workers working on it. The water surrounding the area is surprisingly clean and blue." said Nguyen Thi Minh Hang, 2008 MBA. The Incheon Bridge is due to be open to the public in 2009 and will be the second connecting bridge between Yeongjong Island and Incheon. Its construction is expected to cost over \$2.5 billion.

Counter-arguing the negative influences on teenagers, the opposition argued that it has more to do with parenting.

The last point made by them was that the fashion industry is a free market and is run according to the law of capital markets. As long as consumers want super-skinny models,

they will be hired. Where there is a demand, there is a supply.

Busan, the City of Multiculturalism

With nearly four million people living in it, Busan is South Korea's second largest city and has the country's largest seaport. With sailors from all around the world trooping through and few tourists these days, the city has quite an international flair.

Haeundae Beach

It used be known only for its hot springs. Haeundae has become one of the most popular beaches in Korea. During summer vacation, especially on weekends, the area is packed with people. There is a wide range of accommodation, stores and excellent restarants nearby to choose from. Recently the area has been filled up with high-rise buildings, trendy shops and open cafes which are popular among youngsters.





Jagalchi Fish Market

Jagalchi Fish Market is one of the must-visit places in Busan. The market is located right next to Busan Harbor and carries a huge selection of fresh seafood. The western section of the market mainly deals with live and freshly caught seafood. Fish and shellfish are caught daily and sold right off the boat. Here you can choose any kind of raw fish and enjoy them at reasonable prices. By Train: Take a KTX train from the Seoul Station to the Busan Station. It takes approximately 3 hours and costs KW47,900 (one-way) during weekdays and KW51,200 on weekends.

By Air: Take a flight from the Kimpo International Airport to the Gimhae International Airport. It takes 40minutes and costs from KW 60,000 to KW100,000, (one-way) depending on what day of the week you take it.

Life After the KDI School

Life at Cornell - Jin-Man Kim (2007 MBA, GMP)



Q1. What are you studying at Cornell?

I am in my 2nd year of GMP Program, currently studying the Master of Professional Studies in Industrial and Labor Relation at Cornell University. The MPS-ILR program is designed for students who are or have been working in human resources, dispute resolution, collective representation, or other labor-related fields and wish to enhance their understanding of the subject matter. It is similar to MILR (Master of ILR) at other schools, which is usually a two year course, but MPS-ILR at Cornell is just for one year and requires an MPS research project paper. Most of the Korean students at Cornell are enrolled in MILR and I'm one of them. The courses offered are mostly related to the IR & HR issues such as collective bargaining, dispute resolution, human resources, organizational behavior, labor economics, and international and comparative labor. In order to apply for this degree, you need to be sponsored by a private organization or the government.

The primary residential for the MPS program that I'm enrolled in, is Ithaca, the New York campus. The school also offers a New York City-based MPS program for the professionals working in the metropolitan area who wish to study part-time. It is for American citizens only though.

Q2. How's your life at Cornell?

I love the life here at Cornell. I have never lived in the U.S. before. Although Ithaca is not an urban city it is only a 4 hour-drive away from the New York City. The campus is surrounded by many parks and ponds. On weekends, I go on picnics with my friends and barbeque. I'm very satisfied with the quality of classes and competency of the faculty members here at Cornell.

The Cornell ILR School is best known for its HR and IR programs and I'm grateful for being given the opportunity to study here. It is still hard for me to fully understand and comprehend lectures, but my experience at the KDI School helped me a lot to quickly catch up with the study at Cornell. For instance, Dispute Resolution at the KDI School taught by Professor Jin Park and Professor Dong-Young Kim has been a great help with the Collective Bargaining classes here.

Q3. How did you prepare to apply to Cornell and any tips for those who are interested in going to Cornell?

First of all, those of you who are working in the HR-related field should definitely think about applying for the MILR Program. Cornell provides you with a great education and helps you build a good network with other HR professionals and give you an opportunity to advance your career in the field. The requirements for admission are a TOEFL score, GMAT or GRE score, resume, essay, and 2 letters of recommendation. In my opinion, the most important qualification is the GMAT (or GRE) and TOEFL score, and the essay. Although there is no minimum score for GMAT or GRE, you should obtain above-the-average score and the result needs to be submitted no later than early August.

I strongly recommend you to have your essay and resume proofread professionally by a native English speaker before sending your application.

Overall, there is no single criteria that guarantees you an acceptance into Cornell but your efforts will be taken into consideration.

If you have a passion for HR and IR, Cornell is the place for you!

"Age is Just a Number"

Interview with the Alumni President - Heung Lae Kim (2002 MPP)

I was immediately impressed by the beautifully and thoughtfully groomed little garden in front of Mr. Kim's Chinese restaurant, Congee Gogo. 15 minutes after I arrived at the restaurant, he rushed in with his wife and apologized for being late. "I'm so sorry for being late. I had to go to the City Terminal to pick up fresh abalones coming directly from Mokpo. This is something I try to handle personally." I expected him to be authoritarian, considering that he had worked for the bureaucratic government for so long. To my pleasant surprise, he was a very humble person and full of energy.

Right after he resigned from the office of Vice-Minister of Home Affairs in 2001, he started his study at the KDI School. He was 60 year old and had work experience of 36 years under his belt at that stage. Most people would say that it is time to take a rest. But not our Mr. Kim. While attending the KDI School he spent days and nights studying and even went to Rutgers University in the US for 1 year to pursue a degree in Political Studies.

After finishing his studies, he was appointed to a director at Korean Local Administration Office and Dean at Dankuk University. Last year, he resigned from Dankuk University and decided to open his own Chinese restaurant. He wanted to do something he can do for the rest of his life with his wife.

"I don't want to just sit back at home doing nothing for the next 20 years. I believe keeping myself busy and enhancing myself is the secret to staying young." He also added, "There are 5 ingredients to a happy life: 1. Good health, 2. Reliable and loving spouse, 3. Financial Stability 4. Working to keep yourself busy, 5. Good friends."

My life meets all of the 5 requirements. Since I opened the restaurant, I have become healthier, am able to spend more time with my wife, and am financially independent.

My restaurant business keeps me busy and lets me see my friends more often than before because they now can come here for meetings and family gatherings."

In a little over an hour at the dinner table, he shared his beliefs and his view of life with me. I was deeply touched by his "passion" for life and I couldn't help thinking that his age, 67, is just a number and he is surely young at heart.

Interviews with Faculty

Professor In-Koo Cho

Professor In-Koo Cho is a renowned game theorist and researcher who teaches "Understanding Strategic Behavior" at the KDI School during the first term of summer semester each year. He has been teaching at the KDI School since 1998 and holds the formal investiture as William S. Kinkead Distinguished Professor of Economics. From 1991 to 1995 he held the distinguished position as an Alfred P. Sloan Research Fellow that is awarded only to the very best young faculty members.

e was an Associate Professor at Brown University from 1995 to 1996 and held a Professor position from 1996 to 1998. Professor Cho holds a Bachelor of Arts degree in Economics with Magna Cum Laude at Seoul National University and a Ph.D. in Economics from Princeton University.

The William S. Kinkead Distinguished Professorship in Economics was established in 1982 with a gift from the William S. Kinkead Charitable Funds. It was created to honor an individual who "displays a commitment to the study and enhancement of an efficient market economy as reflected in topics such as, but not limited to, microeconomics, industry enterprise economics, the theoretical and applied role of innovation and technological change, economic growth, and market structure in the functioning of the American economic system." These characteristics can be found in Professor Cho's works.

During the interview with Professor Cho, he explained that teaching at the KDI School is quite a change from teaching at the University of Illinois. At Illinois, he is teaching undergraduate and Ph.D. students whereas at the KDI School, students are graduate students and most of them are government officials.

When asked about his feelings about visiting Korea, specifically the KDI School every summer, he responded that he is very satisfied with the arrangement. It is very convenient and fits in with his tight schedules perfectly. "The KDI School has a very good infrastructure to accommodate visiting professors." he said.

He will be teaching a MPP course at the KDI School next year. Don't miss a chance to learn from this fine scholar, if you're interested.

International Masters Program in Practicing Managements (IMPM) Reported by Andrea Bono 2008 MPP, Guatemala







During the last week of May, the KDI School had a privilege of hosting the International Masters Program in Practicing Managements(IMPM). The IMPM is a graduate management development program.

It consists of five fortnightly modules spread over 16 months and is held in six different countries; United Kingdom, Japan, Canada, India, Korea and France.

Different from an MBA program, the IMPM is designed for senior managers who are, on average, over 35 year old and usually with work experience of at least 15 years. It focuses on mindsets, reflections and insights. Half of the class-time is for the participants to focus on their chosen agenda. The classes are designed to incorporate the perspectives of the participating managers .It uses their own experiences as the basis for case-studies and encourages them to apply their insights to improve managerial skills.

This year, 30 managers from 7 different countries, Canada, Japan, Sweden, France, Germany, India and Korea participated. It is a promising rise from 26 participants in last year.

Special Lecture: Korea, Writing Another Chapter on the Miracle



On July 2, 2008, the KDI School invited members of the diplomatic community and multinational corporations to a special lecture by Dr. Moon Joong Tcha. 

research institution located in New York State. It was named in the top 25 schools of public administration and policy.



The SDA Bocconi School of Management is one of the top business schools in Milan, Italy and has been internationally recognized as a leading management school. It offers a



SSRN Business School Ranking

The papers written by the KDI School's faculty turned out to be the most popular and most downloaded among Korean business schools for the second year in a row. The Social Science Research Networks (SSRN) with the world's leading social science research database released its rankings of international business schools. The SSRN ranking report showed that in the last 12 months, the KDI School has uploaded 19 new papers and its papes have been downloaded 3,957 times.

The SSRN database is used by over 35,000 people in approximately 70 countries and its rankings, demonstrate a high level of credibility received from the public and academic community as the surveys are conducted among professors and researchers.

The papers from the KDI School were ranked the most downloaded among the business schools in Korea. With Korea University in the second place, Seoul National University is ranked to the third place, followed by KAIST and Yonsei University. It demonstrates that the KDI School has been recognized internationally for its high-quality research papers.


G: Why would you recommend our readers to visit Lithuania?
