Weare delighted to hear about your interest in considering launch of studentexchange program with us.

Our existing graduate student exchange programme between GSPP and the Lee Kuan YewSchool of Public Policy at the National University of Singapore (LKYSPP)started in 2016.

## **Number of Students**

EachSchool would host up to a maximum three students from the partner School. Thesestudents would be selected on a competitive basis according to the criteria setby each School.

GSPPhas hosted 6 students from LKY SPP (citizens of China, India, Philippines, Singapore, USA), and sent 5 students for AY 2016-2017 and 2017-2018.

# **Duration of Exchange**

Each exchange student spends a full semester at the partner School. It is usually their 3<sup>rd</sup> semester in MPP program. Total MPP program duration is 4semesters operated in Fall and Spring semeters.

## Credit Transfer of ModulesRead

Each exchange student is usually registered to read 4 modules at the partner School. This allows issuance of student visa, and meeting program requirements at host Institution. Each module read at LKYSPP is recognised as equivalent to 8 ECTS points at NU and each module read at GSPP is recognised as equivalent to 4 modular credits at LKYSPP.

On behalf of Graduate School of Public Policy (GSPP) at Nazarbayev
University, I would like to thank the KDI School for the opportunity
provided in strengthening our partnership through our existing Memorandum of
Understanding (MOU) that has been signed between Nazarbayev University and
KDI School. In this regard, we would like to propose a launch a tangible
collaboration between our institutions through an academic exchange program
for our students.

Our particular interest in this student academic exchange program stems from the feedback we received from our Master in Public Policy (MPP) students. In late February 2018, three of our MPP students had the opportunity to participate in the 2018 NASPAA Student Simulation Competition held at the KDI School.
